Rules: USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used. Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office. A donation to GCC would be appreciated for admittance of horses not to be shown.

Directions: From South: North on Hwy 66 to Foyil; At Foyil take 28A East for exactly 5 miles; 28A comes to an end at the bottom of the hill; Turn left on Hwy 28 West and go 2 ½ miles. Farm is on the right.
From North: Hwy. # 66 south to Chelsea. Turn east on Hwy 28 and go 5 miles. Farm is on the left.

Entries must be received by closing date at 5:00 p.m. Phone, email and late entries may be refused. A late fee of \$20 will be charged at the discretion of the show management. If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10.00 office fee. All no-show entries will be billed to the rider.
