RULES: USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used (GAG tests are 1991 version). Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office.

Directions: **FROM TULSA** - take I44 E, exit 255 (Claremore/Pryor), turn R on Hwy 20, travel approx. 1.1 miles, turn L on S4180/NE Justus. Travel approx. 0.8 m., turn R on E 480/E Blue Starr Dr. Travel approx 1.8 m. (Blue Starr Dr becomes S 4190/NE Ward). Oakbrooke Farm on left.
FROM CHELSEA - take Hwy 66 to Sequoyah. Turn left on NE Akin Rd/EW 450. Travel approx 1.2 miles (E). Turn R on S4190/NE Ward RD, travel approx 1 mile, Oakbrooke Farm on Right

If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10 office fee. All no-show entries will be billed to the rider.
