RULES: USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used (GAG tests are 1991 version). Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office.

Directions: **FROM SOUTH-(Adair, OK)** travel West on Hwy 28, turn right (North) on Hwy 28. Go 2 1/2 miles. Farm on right

FROM SOUTH-(Claremore, OK) travel North on Hwy 66. At Foyil take 28A East for 5 miles, turn left (N) on Hwy 28,

Go 2 1/2 miles, Farm is on the right.

FROM NORTH - (Chelsea, OK) 66 south the Chelsea, turn East on Hwy 28, go 5 miles, Farm on left

Show management reserves the right to change ride times when deemed necessary to facilitate timely completion of the show. Entries must be received by closing date at 5:00 p.m. Late entries may be refused or charged a late fee of \$20 at the discretion of the show management. If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10 office fee. All no-show entries will be billed to the rider.
